When children arrive at Carolina Youth Development Center (CYDC) they are in need of a safe, stable place to call home. CYDC has become that home for thousands of children and youth over its 230-plus years of providing services and supports for children who have experienced trauma in our community. Known for its reputation as a leader in the state of South Carolina for providing comprehensive treatment for children and adolescents who have experienced emotional, physical and sexual trauma, CYDC continues serving the community with various programs including four residential care facilities to provide temporary and/or long-term care for children and youth suffering from the impact of emotional, physical and/or sexual abuse. The four facilities included the Charleston Emergency Shelter (CES), the Ledford House, the Callen-Lacey Center for Children (CCLC) and the newly opened NuHouse.

Opening in April 2019, NuHouse in North Charleston provides transitional housing for youth aging out of foster care. Young adults ranging in age from 18 to 21 years old live in a supportive environment that focuses on helping young adults transfer with skills and confidence to living independently.
