Freedom Schools program boosts student motivation to read, generates more positive attitudes toward learning, and connects the needs of children and families to the resources of their communities. Opened in late 2018, NuHouse in North Charleston provides transitional housing for youth aging out of foster care. Young adults ranging in age from 18 to 21 years old live in a supportive environment that focuses on helping young adults transfer with skills and confidence to living independently.

While at CYDC, children are not only provided with a safe and supportive environment that helps introduce normalcy and consistency into their daily lives and activities, they also receive important trauma-informed assessment and support services designed to address each child's individual educational, emotional, physical and social needs. CYDC assists in the transition of the child back to home, to a more permanent home environment or to independence. At capacity, 68 children ages birth to 21 can be housed in CYDC facilities. The length of stay is typically decided by the South Carolina Department of Social Services and the court system, but stays can range from a few days to a few years. In 2019 the average stay was 180 days per child. CYDC's programs have been continuously accredited by the Council on Accreditation (COA) since 1980.

Family Engagement Services

In partnership with the National Youth Advocate Program, CYDC facilitates Family Engagement Services, designed to empower families whose children are involved in the child welfare system and to assist those families in developing plans to ensure the safety and well-being of their children.

CYDC's Bakker Career Center and Center for Life are located on the North Charleston campus and provide educational and job skills training as well as enrichment activities like music, art and recreation to CYDC residents and youth in the community. Programming includes partnerships with local job training programs, artists, volunteer mentors and area businesses.

Impact of 2020 Coronavirus Pandemic

The unprecedented 2020 Coronavirus Pandemic had a tremendous impact on CYDC. Fundraising was compromised as in-person events were cancelled, community-based programming shifted to virtual platforms when possible and staffing patterns expanded as children in residence at CYDC transitioned from in-person school to an on-campus virtual school model. CYDC responded quickly to make strategic investments to prioritize the safety of children, families and staff by implementing new policies, screening and cleaning

protocols, adapting programming and issuing PPE. When schools dismissed early and started late, summer programming was expanded from 6 to 11 weeks. A Paycheck Protection Program loan was awarded and forgiven, offsetting the revenue lost from cancelled events.

Throughout the pandemic and despite unanticipated challenges, CYDC was able to ensure that its doors remained open and essential services were delivered to children and families in the Lowcountry.
